Symptoms Caused by Exposure:

Inhalation: Irritation of nose, throat and respiratory tract.

Skin contact: Redness, dryness and irritation. Eye contact: Redness, stinging and irritation.

Ingestion: Nausea, vomiting, dizziness, headache and blurred vision.

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES
